All the service providers to SSKSB viz Ponywallas, Palkiwallas, Pithoos who are already registered with SSKSB & are plying on SSKSB track are directed to submit their filled applications forms along with requisite documents (DOB certificate, Medical certificate, Character certificate, affidavit & photograph etc.) in the SSKSB at Ransoo for renewal of their identity cards/licenses, so that illegal Ponywallas be checked properly. The requisite information must reach in the SSKSB office Ransoo latest by 15th of June 2015 thereafter, no forms shall be considered for renewal.

Those existing registered services providers (mentioned above) who fail to submit their applications forms within stipulated time period shall not be considered again & their right for plying on track shall automatically be forfeited & others shall be considered in their place.

ORDER

During tour of the undersigned to Shivkhori/Ransoo on 27-05-15:

1. Many minor children & others were seen who were operating/plying ponies on SSKSB track without their proper identity due to which it is too difficult to control/monitor them as they are not registered with SSKSB. This practice also encourages overcharging to the pilgrims by the different service providers, particularly Ponywallas. Even some on spot complaints against Ponywallas were received from the pilgrims. To maintain discipline/decorum on this religious place, so that a good message is spread among the tourists/pilgrims & more pilgrims are attracted towards this ancient Shrine, **all the Temporary Permissions issued from SSKSB office Ransoo are cancelled.**

Further all Existing registered Ponywallas are directed to submit their filled forms along with requisite documents (DOB, Character, Medical Certificate, affidavit etc.) to SSKSB office at the earliest, so that their Identity Cards may be renewed again.

2. Some pilgrims were seen bathing with soap at Doodh Ganga. At this location water is very deep & as reported many mis-happening have occurred in past. **Soap, detergent & other chemical items which pollute water are strictly banned, particularly at Doodh Ganga in the Shrine area.**
3. **Polythene bags are already banned by the District Administration in the whole district. So Polythene bags & use of other plastic items like cup etc. are also banned in the Shrine area.**
4. Employees are directed to ensure that each counter is opened timely & **to remain punctual towards their duties.** They are also directed to wear uniforms & Identity Cards.

Strict action against defaulters/violators shall be taken henceforth under rules.
